Public hearing for purpose of discussing de-annexation of Rolling Oaks Subdivision from Berryhill Fire Protection District was called to order at 9:52 a.m. Clay Edwards, Chief Deputy for Board of County Commissioners, stated there are 116 owners in Rolling Oaks Subdivision. Sixty-four signed in favor of de-annexation, which is five more then needed by law. After researching the law, he feels this petition is in order. Selph cited Statute 901.23 and read letters from Loy Calhoun (City Manager) and Russell Bartling (Retired Fire Chief) for the record. Selph asked if anyone present wished to speak for or against petitions. Mark Way and Dennis Hudson (homeowners) stated they are being assessed twice for fire protection and letter presented from Stephen M. Buck requested that Shenadoah also be de-annexed at this time. Waymon Ray, Chairman of Berryhill Fire Protection District, stated due to this de-annexation they will lose 1/5 of their budget and would like for these petitioners to reconsider. They have offered to reduce their assessment of 7 mills to 3-1/2 mills. They are willing to contract services with homeowners on a separate basis if insurance will allow this. Under mutual aid agreement, Berryhill Fire Protection District will continue to respond, but those homeowners still belonging to the district will
