That the Cost Bond filed herein be and the same is hereby accepted, approved and ordered filed.

That three disinterested, impartial resident freeholders of Tulsa County, not of kin to interested parties, be selected and appointed by this Board as viewers, to view, under oath, the line of the proposed improvements, and properties adjacent thereto, and report in writing thereon in the manner and as provided by law, and in the order of their appointment, as to the public necessity and practicability of such proposed improvements.

Done in open meeting of said Board of County Commissioners this January 9th, 1943.

Thereupon, upon roll call, each Commissioner voted in favor of the adoption of said resolution, and the Chairman declared same adopted.

RESOLUTION AND ORDER OF COUNTY COMMISSIONERS APPOINTING VIEWERS OF TULSA COUNTY DRAINAGE AND IMPROVEMENT DISTRICT NO. 12.

Now on this the 9th day of January, 1943, at a regular meeting of the County Commissioners held at the Courthouse in said County, the matter of appointing viewers for Tulsa County Drainage and Improvement District No. 12, as provided by Title 82, Sec. 302, of Oklahoma State Drainage Act, Oklahoma Statute 1941, coming before said Board, and it appearing that the petition praying for the creation of Tulsa County Drainage and Improvement District No. 12 is on file and now pending before this Board, and that Bond for costs has been filed and approved, and this Board should now appoint three resident viewers, qualified as provided by above statute, to view and report in writing, on the practicability and necessity of such proposed improvements in the above named Drainage and Improvement District, and as more fully described by petitioners in their petition filed herein.

NOW, THEREFORE, BE IT RESOLVED THAT METTITT J. GLASS, RAY H. BROWN AND ROBT. G. FRY, each disinterested resident freeholder of Tulsa County, not of kin to any person interested in said proposed improvement, and in every way worthy and qualified to act as such, be and they are hereby appointed viewers and directed to proceed at once, after taking the oath required by law, to go upon said premises, described in the petition herein and view the line and location of the proposed levees, drains, ditches, channels and other kinds of proposed levees, drains, ditches, channels and other kinds of proposed improvements and report to this Board in writing, after actual view of said premises or adjacent premises thereto, whether or not such proposed improvements are practical and necessary or of private or public utility and benefit; and, if the viewers find that such proposed improvements are practical and necessary or of utility and benefit, they should report the best route for such proposed improvements; and also, whether or not any bridges are necessary and whether such construction work should be let to several interests or by contract without allotment.

The County Surveyor and Special Engineer, if required, are hereby directed to aid and assist the viewers in the discharge of their duties herein.

Thereupon, a roll call being had upon said resolution, each commissioner voted in favot of its adoption, and same was by the Chairman declared adopted.
