- 1. Memorial Boulevard, otherwise known as the section line and road between Sections 23 and 25, and 25 and 26, from the Quarter Section Corner North of Apache Street, South One-half (1) mile, and to Apache Street a distance of 2640 feet; across the intersection of Apache Street and Memorial Boulevard and South of said intersection a distance of 635 feet to the Southeast corner of Lot 20, of Aerial Heights, a dubdivision in Tulsa County, Oklahoma;
- 2. 33rd Street North from the Eastern boundary thereof, located on the half section line of Section 24, Township 20 North, Range 13 East, West to a point 60 feet West of the Southeast corner if Lot 5, Block 7; 34th and 35th Streets North from the Eastern boundaries thereof; located on the half section line of Section 24, Township 20 North, Range 13 East, West to the intersections of 34th and 35th Streets North with the Eastern boundaries of of 83rd East Avenue; and 84th East Avenue from its Northern boundary, located on 36th Street North, south of its southern boundary, located on 33rd Street North; all in Woodland Park, a subdivision in Tulsa County, Oklahoma;
- 3. 36th Street North from the Western boundary of U.S. Highway 75 to a point 1940 feet West of the Southeast corner of Section 13, Township 20 North, Range 13 East, Tulsa County, Oklahoma;
- 4. All streets, alleys and easements located in Aviation Acres, an Addition to Tulsa, Tulsa County, State of Oklahoma, according to the recorded plat theroe, more particularly described as the South 34 Acres of the Southeast Quarter ( $SE\frac{1}{4}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ) of Section 24, Township Twenty (20) North, Range 13 East, Tulsa County, Oklahoma,

for the purpose of constructing, developing, operating and maintaining an airplace bomber assembly plant together with all accessory buildings, construction, aprons and runways in connection therewith, as a military and national defense project.

Section 2. That the United States of America be and it is hereby granted the right to go into and take immediate exclusive and permanent possession of the above described county roads and highways for the uses and purposes above set out.

Section 3. That an emergency exists for the preservation of the public pease, health, and safety, by reason whereof this  $R_{\rm e}$  solution shall take effect from and after its passage and approval.
