Comes now the said Sunset Gardens Company, a corporation, and shows this Board of County Commissioners that heretofore, on March 7, 1938, there were filed with it by the owner, Sunset Gardens Company, applications in affidavitform, one for the tax year 1931 and one for the tax year 1932, requesting orders of erroneous assessment, respectively, covering the properties and erroneous assessments thereof as set out in the schedule attached to each of said applications, and that thereafter said applications regularly came on in a single case numbered 37,092 for hearing before this Board of County Commissioners in lawful session on March 22, 1938, and after hearing evidence on said applications the said Board entered its order approving the same, finding the allegations of erroneous assessments as therein shown correct and ordering the assessments corrected as per said order; and that certificate of error was issued under the said order by the County Clerk on April 11, 1938.
