WHEREAS, The Highway Department is in need of a larger and heavier truck, and has found that a trade or exchange can be made with Parrish & Clark Company, Tulsa, Oklahoma, for a new Dodge 2 Tom JA 152 Cab & Chassis, Truck, Motor No. T150-2697, Serial No. 82537844, in exchange for the International 12 Ton Truck, and a further consideration of payment by Tulsa County to the Parrish Clark Company, the sum of Two Thousand Four Hundred Eight Dollars and Forty Cents (\$2,408.40).
