WHEREAS, there has been heretofore created under and by vitue of the laws of the State of Oklahoma, a system of roads and highways, to be known as "State Highways" and,

WHEREAS, certain roads and highways in Tulsa County have heretofore been designated as such "State Highways", and

WHEREFORE, said Tulsa County still has undersignated about 15 per cent of the mileage of such roads to which it is enetiled; add,

WHEREFORE, the State Highway Engineer and Board of County Commissioners are empowered and vested with authority to designate and recommend such roads as "State Highways" and

WHEREAS, there is a portion of road which in the opnion of this Board should be so designated to best subserve the Public interests of this State and County, to-wit:

Beginning at a point between Sections 4,5,8 and 9, Township 19 North, Range 13 East, Tulsa County, Oklahoma, and running in an Easterly direction along the Section line between Sections 4 and 9, 3 and 10. 2 and 11, 1 and 12, Township 19 North, Range 13 East; and continuing in said Easterly direction between Sections 6 and 7, Township 19 North, Range 14 East, to a point where said road connects with the said "State Highway Sustem" as already designated.

Also that portion of the road running from the "State Highway" in a Southerly direction along the Township line between Section 1, Township 19 North, Range 13 East, and Section 6, Township 19 North, Range 14 East, to connect with the said above proposed "State Highway" all of which is shown by "EXHIBIT A", attached hereto.

BE IT THEREFORE RESOLVED, by the Board of COUNTY COMMISSIONERS of Tulsa County, Oklahoma, that the above mentioned and described road by, and the same is hereby declared to be and is so designated by the said Board as a part of the "State Highways" of the said County of Tulsa, State of Oklahoma, the same being hereby respectfully submitted to the Honorable State Highway Engineer for his sanction and approval in order that the said road designated herein may be included within the "State Highway System" within Tulsa County, State of Oklahoma.
