ORDER OF PETITION.

Now, on this 27th day of June, 1923, the Board of County Commissioners of Tulsa County, Oklahoma, being in regular session, the matter of granting of an easement and franchise of certain petitioners petitioning for the granting of the privilege of constructing a number of telephone lines along portion of the public highways, said petition being in writing and signed by the EAST TENTH STREET TELEPHONE COMPANY, Ralph R. Johnson, President.

The Board being fully advised in the premises finds that the prayer of said petitioner should be allowed, and it is so ordered that an easement and franchise be granted by the said Board to said petitioner permitting it to construct and operate and maintain a number of telephone lines along the portion of the public highways as follows, to-wit:

Main Line, beginning at a point in the public highway near the Northwest corner of Section 9, Township 19, North, Range 13 East, at Kendall College to Tulsa Oklahoma thence running East, on the South side of the section line or public highway, four miles, to the Northeast corner of Section 12-19-13. Then to cross the said public highway to the Southwest corner of Section 6, Township 19, North, Range 14 East, thence running East on the north side of the section line or public highway five miles east to the southeast corner of Section 2-19-14.

Another line. Beginning at the Northwest corner of Section 10-19-13, thence running south on the east side of the Section Line or public highway, one half mile, to the Southwest corner of NW4-10-19-13.

Another line. Beginning at the Northwest corner of Section 11-19-13, thence running south on the east side of the section line or public highway one half mile to the Southwest corner of NW4-11-19-13.

Another line. Beginning at the northwest corner of Section 12-19-13, thence running South on the East side of the Section line or public highway, tow miles, to the northwest corner of Section 24-19-13, with a branch line thereon, beginning at the south west corner of Section 12-19-13 and running West on the North side of the section line or public highway, one half mile to the Southwest corner of SE4-11-19-13.

Another line. Beginning at the Northwest Corner of Section 12-19-13, thence running North on the East side of the Section line or public highway one mile, more or less to the hard surfaced highway on the original Cherokee and Creek line.

Another line. Beginning at the Northwest corner of Section 8-19-14, thence running South on the East side of the section line or public highway, three miles, to the Southwest corner of Section 20-19-14 thence running east, on the north side of the section line or public highway one half mile, to the Southeast corner of SW4-20-19-14.

Another line. Beginning at the Northwest corner of Section 8-19-14, thence running North on the East side of the section line or public highway, one and one half miles, to the Northwest corner of SW432-20-14, with a branch line thereon, beginning at a point where the present hard surfaced highway intersects with the public highway between sections 5 and 6, 19-14, thence running east on the south side of the section line or public highway, one and one half miles, to the northeast corner of SW4-19-14. With a second branch thereon, beginning at the same point and running west on the south side of the section line or public highway one mile, to the northwest corner of NW4-19-14.

Another line. Beginning at the northeast corner of section 8-19-14, thence running south on the west side of the section line or public highway, two miles to the southeast corner of SE4-17-19-14 thence running west on the north side of the section line or public highway, one half mile, to the southwest corner of SE4-17-19-14.

Another line. Beginning at the northeast corner of Section 9-19-14, thence running South, on the west side of the section line or public highway, two miles, to the southeast corner of Section 16-19-14. With a branch line thereon, beginning at the north east corner of Section 16-19-14, thence running East on the south side of the section line or public highway, one half mile, to the northeast corner of the NW4-15-19-14.

Another line. Beginning at the Northeast corner of Section 11-19-14, thence running east on the south side of the section line or public highway, one half mile, to the northeast corner of Section 12-19-14.

Another line. Beginning at the Southeast corner of Section 2-19-14 thence running north on the west side of the section line or public highway, one half mile, to the north east corner of SE4-2-19-14.

In all a distance of 27 miles along the public highways.

The poles and wires of said lines to be located as directed by the County Engineer of Tulsa County, and so as not to interfere with the full use of the highways by the public, and so as not to interfere with the working of or repairing said highways. Also, so as not to interfere with the rights of property owners along that portion of the public highway traversed by said telephone lines, leaving unobstructed by wires and poles all ways of ingress and egress.
