O R D E R

Comes now, Oklahoma Natural Gas Corporation, a corporation organized and existing under and by virtue of the laws of the State of Maryland, with offices in Tulsa, Oklahoma and hereby petitions your Honorable Board for the right to lay a pipe line along, under and across certain highways, as shown by accompanying plat, and described as follows:

Within highway along the west side of the NW/4 of Section 34, Township 19 North, Range 12 East, said highway known as 33rd. West Avenue said line to be 8 feet west of the east property line; thence across 51st. Street, being highway along the north side of the NW/4 of said Section 34; thence east along said 51st. Street and 8 feet south of the north property line. A 4" gas pipe line, known as service line, City of Tulsa.

And, it further appearing from the petition herein that said pipe line will be constructed so as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.
