

MONDAY, DECEMBER 9, 1946

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock A. M. with all members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the following resolution organizing Water Improvement District to be known as Water Improvement District No. 16 of Tulsa County, Oklahoma, be and the same is hereby adopted, and the Chairman of the Board is hereby authorized to execute same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

RESOLUTION

BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, and it is hereby found and determined by this Board, after being fully advised in the premises, that a special election was held on December 3, 1946, wherein the following proposition was submitted:

"Shall a water improvement district be established and organized pursuant to Chapter 7, Title 82, O. S. 1941 (Paragraphs 771 et seq), including the following territory:

Beginning at a point in the north line of Section 4, Township 19 North, Range 12 East, 370 feet east of the Northwest corner of said Section 4, thence south 278 feet; thence west 370 feet to the west line of said section 4; thence south to the northwest corner of the southwest quarter (SW $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of said Section 4; thence east to the northeast corner of the southwest quarter (SW $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of said Section 4; thence south to the southeast corner of the southwest quarter (SW $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of said Section 4; thence west to the southwest corner of the east half (E $\frac{1}{2}$) of the southwest quarter (SW $\frac{1}{4}$) of the northeast quarter (NE $\frac{1}{4}$) of Section 5, Township 19 North, Range 12 East; thence north to the northwest corner of the east half (E $\frac{1}{2}$) of the southwest quarter (SW $\frac{1}{4}$) of the northeast quarter (NE $\frac{1}{4}$) of Section 5, Township 19 North, Range 12 East; thence west to the southwest corner of Lot 2 of said Section 5; thence north to the north quarter corner of said Section 5; thence east to the southwest corner of Section 32, Township 20, North, Range 12 East, thence north 660 feet; thence east to the north and south center line of said Section 32; thence south 660 feet to the south quarter corner of said Section 32, thence to the point of beginning, all being situated in Tulsa County and Osage County, Oklahoma."

The results in all the precincts for the election have been duly certified to this Board and the total number of persons in the precincts was: 50. The results of said election as canvassed are as follows:
