Motion was made by Ira Short, that P.M.Boysinger, R.F.D. c/o Horace Perkins, Broken Arrow, Oklahoma, be granted an allowance in the amount of Ten (\$10.00) Dollars. Motion was duly seconded by F.M.Wooden, and was by the Chairman declared carried.

Motion was made by Ira Short, Seconded by F.M.Wooden, that the claim of Dr. E.M.Lewis, be and the same is hereby allowed. This claim is in the amount of \$62.50 for the care of Roy Bolton, Special Traffic Enforcement officer, who was injured while on duty. Motion carried.

Motion was made by W.L.North, seconded by J.S.Shaver, that the County Clerk be instructed and authorized to advertise for bids on the County Printing. Said Bid to be let to the lowest and best bidder therefor. Motion carried.

Motion was made by W.L.North, that Mr.J.S.Shaver be made Purchasing Agent on small amounts not to exceed \$200.00, and for more than \$200.00 to be taken up with at least two members of the Board of County Commissioners. Also, the County Clerk is hereby authorized and instructed to notify all officers that all orders shall be approved as herein set forth. Motion carried. Motion seconded by Ed W.Hedgecock.

Motion was made By W.L.North, seconded by J.S.Shaver, that an allowance of \$10.00 per month be granted Mrs. Jane Musgrove, RFD#6, Box 564, Tulsa. Motion carried.

Motion was made by W.L.North, seconded by J.S.Shaver, that the allowance now being paid May Green, or her father, J.M.Brown, in the amount of \$8.00, be and the same is hereby ordered cancelled. Motion carried.

Motion was made by W.L.North, seconded by J.S.Shaver, that Mr. Dan W.Patton, be and he is hereby re-appointed to serve the County of Tulsa in the capacity of County Engineer. Motion carried.
