NOW, THEREFORE, be it and it hereby is resolved by the Board of County Commissioners of Tulsa County, Oklahoma, that an election shall be and is hereby ordered to be held in the territory included within the proposed district as herein amended on the 26th day of August, 1941, from six o'clock A.M., until seven o'clock P.M., and that at said election there shall be submitted to the qualified electors therein to be by them voted upon the following proposition:

"Shall a water improvement district be established and organized pursuant to the provisions of House Bill 181 adopted at the 1925 session of the Legislature of the State of Oklahoma (Chapter 145, Session Laws of Oklahoma, 1925) including the following territory:

All of that land situated in Sections Three (3), Nine (9), and Ten (10), of Township Nineteen (19) North, Range Eleven (11) East, Tulsa County, Oklahoma, lying within and with boundaries as follows, to-wit: All of Charles Page Home Acres Subdivision No. Two, all of Charles Page Home Acres Subdivision No. One except Block Number Four (4), all of Hall's First Addition to Sand Springs, all of Hall's Garden Addition to Sand Springs, that part of the South Half ( $S\frac{1}{2}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of Section Ten (10) lying North of the North right-of-way of the county highway, and all of the remaining portion of the North Half ( $N\frac{1}{2}$ ) of North Half ( $N\frac{1}{2}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section Ten (10) lying North and East of the North right-of-way line of the county highway and the East One Half ( $E\frac{1}{2}$ ) of the Southwest One Quarter ( $SW\frac{1}{4}$ ) of the Southeast One Quarter ( $SE\frac{1}{4}$ ) of Section Four (4), Township Nineteen (19) North, Range Eleven (11) East, Tulsa County, Oklahoma, and less the following described property: Lots Ten (10) and Eleven (11) in Block Two (2), Hall's Garden Addition to Sand Springs; and Lot Nine (9) in Block 10 and Lots One (1), Two (2), Three (3), and Four (4), in Block Eleven (11) in Charles Page Home Acres Subdivision No. Two.

Said election shall be conducted in accordance with the general election laws, and the regular election officials shall conduct the election at the usual or designated polling places for each regular precinct or part thereof within the proposed district, and the returns of said election shall be filed with the Board of County Commissioners.

The County Clerk is hereby directed to cause notice of such election to be given in full compliance with the requirements of the law and in particular to give two weeks notice by publication in the Sand Springs Leader, a newspaper printed in the County, of general circulation in the territory proposed to be included within the district, which notice may be substantially the following in form:

Public notice is hereby given that an election will be held on the 26th day of August, 1941, from six o'clock A.M., until seven o'clock P.M., at which election there will be submitted to the qualified electors in the territory hereinafter described to by them voted upon, the following proposition:

All of that land situated in Sections Three (3), Nine (9), and Ten (10), of Township Nineteen (19) North, Range Eleven (11) East, Tulsa County, Oklahoma, lying within and with boundaries as follows, to-wit: All of Charles Page Home Acres Subdivision No. Two, all of Charles Page Home Acres Subdivision No. One except Block Number Four (4), all of Hall's First Addition to Sand Springs, all of Hall's Garden Addition to Sand Springs, that part of the South Half ( $S\frac{1}{2}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of Section (10) lying North of the North right-of-way line of the county highway, and all of the remaining portion of the North Half ( $N\frac{1}{2}$ ) of North Half ( $N\frac{1}{2}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section Ten (10) lying North and East of the North right-of-way line of the county Highway and the East One Half ( $E\frac{1}{2}$ ) of the Southwest One Quarter ( $SW\frac{1}{4}$ ) of the Southeast One Quarter ( $SE\frac{1}{4}$ ) of Section Four (4), Township Nineteen (19) North, Range Eleven (11) East, Tulsa County, Oklahoma, and less the following described property: Lots Ten (10) and Eleven (11) in Block Two (2), Hall's Garden Addition to Sand Springs; and Lots Nine (9) in Block Ten (10) and Lots One (1), Two (2), Three (3) and Four (4) in Block Eleven (11) in Charles Page Home Acres Subdivision No. Two.
