R E S O L U T I O N.

WHEREAS, By reason of the unprecedented rains and resultant high waters of the Arkansas River, a large area of property of the Citizens of Tulsa County was affected, and the homes of very many people stood several feet deep in water, and that in many instances the gardens, and crops, generally, were seriously damaged if not entirely ruined, and in other instances, the household goods in many instances representing the total value of the property of the owners was seriously damaged if not completely destroyed.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners, that the County Treasurer be and he is hereby instructed that in the writing of tax receipts of citizens and property owners affected by said highwaters, as aforesaid, that the penalty provided for by law, for failure to pay the Ad Valorem Tax at the time and in the manner provided for by law, be not computed or collected by said Treasurer, and that the Citizens and property owners, as aforesaid, be extended the privilege of paying their Ad Valorem taxes without the addition of the penalty for delinquency until and including the 15th. day of July inst.,
