- 1 - Double 30 foot I Beam Bridge, 24 foot roadway, across Joe Creek between Sections 6 and 7, Twp 19 N., R 13 E., or Mile 1 Section "S".
- 1 - 40 foot Span I Beam Bridge, 24 foot roadway, across Spring Creek, Between Sections 8 and 17, Twp 19 N., R 12 E., or Mile 3 A Section "A-1".
