NOTICE OF WATER IMPROVEMENT DISTRICT ELECTION

Public notice is hereby given that an election will be held on the 7th day of December, 1937, from six o'clock A.M. until seven o'clock P.M., at which election there will be submitted to the qualified electors in the territory hereinafter described to be by them voted upon, the following proposition:

'Shall a water improvement distrist be established and organized pursuant to the provisions of House Bill 181 adopted at the 1925 session of the legislature of the State of Oklahoma (Chapter 145, Session Laws of Oklahoma, 1925) including the following territory:

Commencing at the east city limits of the City of Tulsa and comprising all of the land east of said City limits in the South Half (S_{2}) of Sections One (1); Two (2), and three (3), Township 19 North, Range 13 East, and the South Half (S意) of Sections Five (5) and Six (6) and the Southwest Quarter (SW_{4}^{\perp}) of the Southwest Quarter (SW_{4}^{\perp}) of Section Four (4), and the South Half (S_{2}^{\pm}) of the Southeast Quarter (SE_{4}^{\pm}) of Section Four (4), Township 19 North, Range 14 East and that portion of Section Three (3), Township 19 North, Range 14 East referred to as Murray Hill Addition (unrecorded plat) more particularly described as beginning at the Southeast corner (SE corner) of the West Half $(W_{\overline{z}}^{\frac{1}{2}})$ of the Southeast Quarter $(SE_{\overline{z}}^{\frac{1}{2}})$ of said Section Three (3), thence in a northerly direction a distance of 1254 feet, thence in a westerly direction 439.5 feet, thence in a northerly direction 494 feet, thence in a westerly direction 877.4 feet, thence in a southerly direction 1748 feet, thence in an easterly direction along the south line of said section 1318.2 feet to point of beginning, and the North Half ($\mathbb{N}_{\mathbb{Z}}^{\frac{1}{2}}$) of Sections Ten (10), Eleven (11), and Twelve (12), Township 19 North, Range 13 East, and the North Half $(N\frac{1}{2})$ of Sections Seven (7) and Eight (8) and the Northwest Quarter (NW $\frac{1}{4}$) and the North Half (N $\frac{1}{2}$) of the Northeast Quarter (NET) and the North Half (NE) of the Southeast Quarter (SE $\frac{1}{4}$) of the Northeast (NE $\frac{1}{4}$) Quarter, Section Nine (9), Township 19 North, Range 14 East, and the North Half (N2) of the Northwest Quarter (NW4) and the Northeast Quarter (NE_4^1) of Section Ten (10), Township 19 North, Range 14 East, and the East Half (E) of the Southeast Quarter (SE) of Section Eleven (11), Township 19 North, Range 13 East, except certain portions of said described land which are excluded from this territory. That land which is to be excluded is as follows: The Southwest Quarter (SW1) of the Northeast Quarter (NE1) of Section Ten (10), Township 19 North, Range 13 East; and such lands as lie south of 13th street and west of Darlington Street and of Darlington Street as extended south to the east and west one-half section line of Section Ten (10), Township 19 North, Range 13 East; and the right-of-way of the St. Louis and San Francisco Railway Company; and the South Half ($S_{\overline{z}}$) of the Northeast Quarter (NE_{4}^{\perp}) of Section Eight (8), Township 19 North, Range 14 East, and the Northwest Quarter (NW4) of Section Eleven (11), Township 19 North, Range 13 East, and Lots Three (3) and Eight (8) of Block Six (6), of Eleventh Street acres and Lot One (1), Block One (1), Lots One (1), Two (2), Seven (7), Eight (8), Block Two (2), Lots Four (4) and Five (5), Block Three (3), Lots Four (4) and Five (5), Block Five(5), Lots Two (2) to Eight (8) inclusive, Block Seven (7) in Radio Heights Addition and also the Southwest Quarter (SW4) of Section Two (2), Township 19 North, Range 13 East, which is platted as Sheridan Hills Addition to the City of Tulsa, except Lots Fourteen (14) and Fifteen (15), Block Thirty-Four (34), of Sheridan Hills Addition which two said lots are included in the district. All of said land being situated in Tulsa County, Oklahoma.'
