R E S O L U T I O N

TULSA COUNTY DRAINAGE DISTRICT NO. 12
TULSA-WEST TULSA AND SAND SPRINGS LEVEE
AND DRAINAGE DISTRICT.

WHEREAS, There having been filed with the Board of County Commissioners of Tulsa County, Oklahoma, report by the Board of Viewers, namely, M. J. Glass, Ray H. Brown and Robert G. Frye, comprising the membership of a Board of Viewers appointed by said Board of County Commissioners on the 9th day of January, 1943, following filing of a Petition by Jess Tabor and others petitioning for the creation of a Levee and Drainage District for the Tulsa-West Tulsa and Sand Springs Area, dated 9th day of January, 1943, the name of said proposed Levee and Drainage District designated as Tulsa County Drainage District Number 12.

The report of said Board of Viewers bearing date of January 20, 1943, recommends that said District, as proposed, be created and comprise the area confined within the boundaries as set out by description within the said report.

NOW, THEREFORE, BE IT RESOLVED that the report of said Viewers be accepted and approved and that the said Board of Viewers, namely, M. J. Glass, Ray H. Brown, Robert G. Frye, having completed the duties and responsibility imposed upon them by law are hereby relieved from further duties and responsibility in connection with the said proposed levee and Drainage District.

BE IT FURTHER RESOLVED, that the time of hearing upon said Petition and the report by said Viewers be and the same is hereby fixed ~~at~~ as the 15th day of February, 1943, at 10 o'clock A.M., and the place of said hearing be the office of the Board of County Commissioners of Tulsa County, Oklahoma, located in the County Clerk's Office in the Tulsa County Court House in the City of Tulsa, Oklahoma.
