

THURSDAY, DECEMBER 19, 1946

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with all members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Cash Fund estimate of Needs and Request for Appropriation for the County Highway Restricted Cash Fund of Tulsa County, in the amount of \$5,344.45 be and the same is hereby approved, and the Chairman is hereby authorized to sign same and submit it to the Excise Board for their consideration, Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Cash Fund in the amount of \$18,599.41 be and the same is hereby approved, and the Chairman is authorized to sign same and submit it to the Excise Board for their consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Gray, that upon the recommendation of Dan A. Rowe, County Assessor, the affidavit of erroneous assessment in favor of John D. Lewis for the Free Holiness Church of Union Gardens, in the amount of \$6.72 be and the same is hereby approved, and the County Clerk is instructed to issue Certificate of Error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Standard Paving Company, who was the low bidder, be awarded the contract for the improving of Coyote Trail from Sapuppa- Sand Springs Road to Junction of Mud Creek Road, on Project No. 2-F. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the Contract for the improving of North Cincinnati Avenue from 46th Street North to Sperry - Project I-1, be awarded to the Layman & Company, who was the low bidder. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the contract, Statutory and Performance Bonds on Project I-J, covering the surfacing and improving of the German Church Road from U. S. #75 to West Two Miles, filed by Layman and Company, be and the same are hereby approved, and the Chairman is authorized to sign same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
