

Motion was made by W.L.North, that the report of Mr. Ed O.Cassidy, Special Deputy State Examiner and Inspector be and the same is hereby approved and that proceedings be instituted for the collection of \$45.77 from John H.French, a Justice of the Peace, District No. 16, Tulsa County, Oklahoma, and that the Clerk be instructed to notify Mr. French, at once, in regard to the action of the Board and the order made by them. Motion was seconded by Ed.W.Hedgecock, and was by the Chairman declared carried.

Motion was made by W.L.North, that the Board of County Commissioners approve the extension of contract to Burke Gibbs Construction Company for building of roads as more specifically set out in the order given herewith:

ORDER APPROVING EXTENSION TO CONTRACT  
"80A" To BURKE GIBBS CONSTRUCTION  
COMPANY.

WHEREAS, on the 5th day of October, 1922, a contract was entered into by and between Tulsa County, State of Oklahoma, and Burke Gibbs Construction Company of Tulsa, Oklahoma, for the paving with concrete and otherwise improving

"Miles 5 and 6, of Section T, Tulsa County, State Highway"

AND, WHEREAS, said contract and the proposal submitted provided that extensions to said contract be made,

NOW, THEREFORE, It is the opinion of the Board of County Commissioners that it is to the best interests of Tulsa County that the said Contract be extended to cover the paving with concrete and otherwise improving,

MILES 3 and 4, of Section U, Tulsa County State Highway,

extending in effect the paving to the Town of Glenn Pool,

Tulsa County". Such extension to be made, and the cost thereof to be paid for at the same unit item prices as contained in the original proposal, subject to Contractor filing Statutory and Contract Bond in the amount of approximately \$47,500.00 and the terms of the original contract and specifications to govern as though this extension had originally been incorporated therein.

Upon motion made by W.L.North, seconded by J.S.Shaver, the following motion was made and declared carried:

Motion was made by W.L.North, that the Map of Tulsa County showing the State Road System divided into Patrol Sections be approved as presented by the County Engineer, with the exception of Patrol Section No. 17, which number the Engineer designated as beginning on the North Boundary of Section 14, Township 17 North, Range 12 East, and following thence South along the State Highway as designated by the Board of County Commissioners on the 28th. day of April, 1923, and approved by the Commissioner of Highways on the 2nd. day of May, 1923, and that the same be changed to begin at the corner of Sections 11-12-13 and 14, Township 17, North, Range 12 East and extending South 5 miles; thence West 2 miles to the Tulsa Creek County Line, correcting the map accordingly and requesting the Commissioner of Highways in the name of this Board to change the State Highway to such location without any change, however, being made in that part of the State Highway running between Sections 11 and 14, Township 17, North, Range 12 East to the Town of Glennpool. That this be done for the reason that the location to where the change is sought to be made is now the main travelled road; is reasonably well improved and the road one mile west as designated the dates heretofore set out is not improved, and it would be to the best interest of the County that the same be changed as suggested.

The motion was seconded by J.S.Shaver. Upon roll call the motion received unanimous vote.
