The Board Of Commissioners, of Tulsa County, Oklahoma, met in their rooms at 10.15 A. M. Mr. Avery and Mr. Wooley being present; Mr. Baker, absent. The Board proceeded to audit claims against the County (See Claims) The matter of the care of cases of contagious diseases, was taken up with the Officials of the City of Tulsa. Mayor Wooden, Commissioner In Re. Con- Coley and City Attorney Ramsey being present. It was agreed that the County Attorney and City Attorney, look up the matter.

> The matter of the care of cases of contagious diseases was taken up for consideration again, upon receiving reports of the City and County Attorneys. The City being represented by Mayor Wooden, Commissioner Jay Forsyth and the City Attorney Ramsey. The County being represented by Commissioners Avery and Wooley and County Attorney Malloy. After due deliberation, it was agreed that it was the duty of the City of Tulsa, to care for persons affected with contagious diseases, within the City.

CIk.instruc-The County Clerk was instructed to write the 'Canton Pridge ted Canton Bridge Co Company', relative to re-painting certain bridges.

Upon motion, the following order was made.

ORDER DIRECTING THAT THE CENSUS OF THE TOWN OF SAND SPRINGS, TULSA COUNTY, STATE OF OKLAHOMA, BE TAKEN AND THE MANNER FOR TAKING SAID CENSUS:

IT IS HEREBY ORDERED AND DECREED, that the Census of the Town of Sand Springs, Tulsa County, State of Oklahoma, he taken and that the said Ross H. Rayburn, a proper and qualified person, be hereby instructed to take an innumeration of the inhabitants of the said Town of Sand Springs, and to report to the Board of County Commissioners, the exact number of inhabitants living in the said Town of Sand Springs.

The said Ross H. Rayburn, is hereby allowed the sum per head for taking said census, and said expense is to be charged and paid by the said Town of Sand Springs, Tulsa County, State of Oklahoma, in accordance with a petition filed with the County Clerk on December 1st., 1913, praying that an innumeration of said inhabitants of said Town of Sand Springs, be taken, in accordance with Chapter 9, Page 121, Section 415, of the Oklahoma Statute for the year, A. D., 1910.
