ORDER APPROVING EXTENSION OF CONTRACT No.92A Bridges and Culverts on Section "Q1" Willow Springs State Highway.

WHEREAS, it was provided in Contract No. "92A" as executed on the 19th. day of April, 1923, by and between the Board of County Commissioners of Tulsa County and A.C.BANCROFT whereby the Contractor was to do certain construction on Section "Q1", that the same may be extended to cover other work upon the saiddhighway at the same prices as provided for in the original proposal and contract.
