THURSDAY, AUGUST 12, 1948

Pursuant to recess heretofore taken, the Board of County Commissioners met at the hour of 10:00 o'clock A. M., with all members present: Roy Evans, Chairman; Claude W. Bailey and John Couch, Members. William P. Gable, Jr., County Clerk.

Roy Evans, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the salary of Robert L. Johnson, Clerk of the Court of Common Pleas, be and the same is hereby increased 20%, effective August 1, 1948.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that Florence Tipton be, and she is hereby approved as a Deputy in the County Clerk's Office, effective August 13, 1948, at a salary of \$190.00 per month, and that the salary of Dorothy Leslie, Deputy, County Clerk, be increased to \$195.00 per month, effective August 1, 1948.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried that the request of the County Treasurer for the installation and rental of two temporary telephones in the Treasurer's Office to take care of the excessive volume of inquiries after the Tax Rolls are certified be, and the same is hereby approved.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried that the appointment of Mrs. Jewel W. Bryan, as a typist in the Court Clerk's office, at a salary of \$180.00 per month, effective August 11, 1948 be, and the same is hereby approved, and that the increase in salary for Floyd Prather from \$175.00 to \$185.00 per month, effective as of August 1, 1948, be and the same is hereby approved.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the Election Payroll for the Run-Off Primary Election, July 27, 1948, in the amount of \$3.00 be, and the same is hereby approved, and the Chairman is hereby authorized to sign same.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the Lease Contract between The Clarence L. Boyd Company, Inc., and the Board of County Commissioners covering 1 Model 512 Adams Motor Grader, Serial #4269, which Lease Contract is filed of record, be and the same is hereby approved.

Motion made by Commissioner Bailey, seconded by Commissioner Evans, and unanimously carried, that the County Clerk be instructed to record Deed, dated July 12, 1948, between Phil B. Drane and Marie A. Drain, and Harold S. and Erna C. Garrett, and Tulsa County covering strips of land located in Section 10, Township 19 North, Range 13 East, to be used for road and highway purposes.
