

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that the Board of County Commissioners of Tulsa County, Oklahoma, and the County of Tulsa Oklahoma, in consideration of the release by the City of Tulsa of all of its claims against said County for all maintenance of the improvement so constructed upon said premises both past and future, hereby release, quit claim, grant, bargain, transfer and convey unto the City of Tulsa, Oklahoma, all of the right, title and interest of said County of Tulsa, Oklahoma, in or to any of the lands operated as the Tulsa Municipal Airport and particularly all of those lands mentioned and described in said easement and which are more particularly described as follows, to-wit:

Tract No. 1.

That part of Section 23, Township 20 North, Range 13 East, in Tulsa County, Oklahoma, described as follows: Beginning at a point 2310.0 feet north of the southwest corner of said Section 23, and running thence, east for a distance of 990.0 feet; thence south 45 degrees east for a distance of 2100.0 feet; thence north 45 degrees east for a distance of 1166.66 feet; thence north for a distance of 990.0 feet; thence north 45 degrees west for a distance of 932.7 feet; thence north for a distance of 660.0 feet, more or less; thence west for a distance of 2640.00 feet more or less; thence south along the west line of Section 23, a distance of 1650.0 feet more or less, to the point of beginning; provided, however, that nothing herein contained shall be deemed or construed to impair any of the rights of the United State of American under its lease dated January 1, 1941, and supplements thereto, covering a portion of said lands, nor any of the right, title or interest of the State of Oklahoma and the Oklahoma National Guard under the said lease of December 10, 1940, it being the true intent and purpose of this release of easement to transfer and convey to the City of Tulsa all of the present right, title and interest of Tulsa County, Oklahoma, in any part of the lands above described together with all of the rights of said County by way of reversion or otherwise, upon the expiration, release or other termination of the said leases to the United States of America, and to the State of Oklahoma and National Guard.

TRACT NO. 2.

ALSO, a tract of land, the southwest corner of which is located at a point 1040.0 feet north of the Southwest corner of said Section 23, and, thence bounded as follows: east, for a distance of 290.0 feet; thence north for a distance of 250.0 feet; thence west for a distance of 290.0 feet; thence south for a distance of 250.0 feet to the point of beginning;

TRACT NO. 3.

ALSO, a tract of land beginning at a point 235.5 feet west and 222.0 feet north of the quarter section corner on the south boundary of said Section 23 and running thence east, for a distance of 500.0 feet; thence north for a distance of 250.0 feet; thence west for a distance of 500.0 feet; thence south for ~~a distance of 250.0 feet to the point of beginning,~~ a distance of 250.0 feet to the point of beginning, all in Section 23, Township 20 North, Range 13 East, in the County of Tulsa and State of Oklahoma.
