## SPECIAL MANAGEMENT CONFERENCE September 27, 1994

The Board of County Commissioners of Tulsa County met at 10:00 a.m., with the following members present: Lewis Harris, Chairman; John Selph, Robert N. Dick. Others present: Stanley Glanz, Bill Thompson, Jim Helm, Jerry Griffin, Michael Brenchley, Brian Hunt, Dwain Midget, David Pauling, Russell Motley, Marshall Stewart, Buck Rudd, Denise Graham, Tom Gillert, Wayne Carr, Neal Kennedy, Lee Allen, Ralph Jones, Bill Knowles, Sally Edmondson, David Winslow, James Hogue, Manny Gammallo, Clay Edwards and Vera Carroll.

Chairman called the meeting to order at 10:04 a.m., and the following business was transacted:

Harris opened discussion on the findings of the United States Department of Justice from their March 29-31, 1994, investigation of the Tulsa County jail.

Harris explained the investigation was to determine the constitutionality of the living conditions in the jail. He said the report states we are in violation of some of the constitutional rights of the prisoners and we have forty-nine days from the date of the report in which to respond.

Harris stated the purpose of this meeting is to discuss remedies we might implement to meet some of the requirements.

Sheriff Glanz submitted a written report which addresses some of the deficiencies noted in the report. He said his office has corrected, or is in the process of correcting, all identified problems for which they have the resources to address.

Following discussion and comments by elected officials and others, the Board concurred they will need time to study Glanz's report. They also determined this subject is to be carried as a regular agenda item while seeking solutions to the problems. Edwards will work on scheduling another meeting soon.
