FRIDAY, July 13, 1923.

The Board of County Commissioners met in their office at the hour of 8:00 o'clock A.M., with all members present.

At a regular meeting of the Board of County Commissioners held in the office of said Commissioners, in the City of Tulsa, on the 13th. day of July, 1923, the following Resolution was introduced by W.L.North, who moved its adoption, and the motion to adopt was duly seconded by Commissioner J.S.Shaver, and the Resolution was ordered read:

R E S O L U T I O N.

BE IT RESOLVED, By the Board of County Commissioners that inasmuch as it is necessary for the Board to ascertain the precise and exact amount due to the various municipalities in the County for penalties on delinquent taxes, for which suits are now pending in the District Court of Tulsa County, that then Honorable State Examiner and Inspector be and he is hereby requested to assign a Deputy State Examiner and Inspector to make a special audit of such penalties, without delay, in order that the amounts that judgment should be rendered against the County in said cases be ascertained so that levies can be made for this Fiscal Year for the payment thereof as by law provided, out of the Sinking Fund.

Meeting called to order, with all members present. The following resolution was ordered made a matter of record:

R E S O L U T I O N.

BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma, in regular session, that the County Clerk be and he is hereby authorized to employ ED O CASSIDY, a Certified Municipal Accountant to prepare the Financial Statement of the following funds: General, Sinking, State Highway Construction and County Road Maintenance and the Financial Statements of the funds of all of the Townships of said County as of June 30th. 1923, Fiscal Year of 1922-1923, and all data necessary to be set out in the County and Township Budgets as of June 30th. 1923, Fiscal Year of 1922-1923, excepting the estimated needs for fiscal year 1923-1924.

And, as compensation for such services said Ed O.Cassidy is to receive the sum of \$25.00 per day, for each day engaged in the work and in order to expedite the preparation of said budgets that said Ed.O.Cassidy be allowed two assistants to be paid the sum of \$15.00 per day for each day actually engaged in the service, and that the County Clerk
