O R D E R

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to W. Roy Smith of a deed conveying to him for a consideration of One Hundred Eighty-Two and No/100 dollars (\$182.00) the following described lots:

AND WHEREAS, the sale of said land by the County Treasurer was made and pursuant to H. B. 121, Section 2 of the compiled Statutes of Oklahoma of 1935, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax resale, and

WHEREAS, due notice has been given and published by the County Treasurer in the West Tulsa News, the official paper of the County of Tulsa, that said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners on Dec. 2nd, 1935, the date specified in said notice, and J. H. Hale and C. R. Morgan having appeared at said hearing and having offered a higher price, to-wit: The sum of \$1.25 per lot for the purchase of said lots and land, than the sum of \$1.00 per lot offered by the original bidder, and the County of Tulsa has no need for said land for any purpose required and provided by law whatsoever.

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treasurer to J. H. Hale and C. R. Morgan for a consideration of \$227.50, and it is hereby ordered that the Chairman of the Board of County Commissioners execute to J. H. Hale and C. R. Morgan a deed conveying to him all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property, and the County Clerk of Tulsa County is hereby directed to attest with his signature the seal of his office.
