Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, Application and Resolution submitted by A. M. Covington, Attorney for the Jacobson's Lifetime Buildings, Inc., be and the same is hereby adopted:

RESOLUTION of ABANDONMENT

A resolution abondoning street improvement district upon showing the improvement to said streets has been done by private persons and concerns since the creation of said district and rendering unnecessary a further continuation of said proceedings.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA:

- l. It has been made to appear and the Board of Commissioners having been satisfied that all street improvements contemplated in the street improvement district herein established have been made and completed by private persons and concerns and without expense to Tulsa County, the creation and establishment of the Street Improvement District #1, Tulsa County, Oklahoma, is hereby abandoned, vacated and set aside.
- 2. That Tulsa County shall bear no expense of the work having been done to said streets, including costs of engineering, attorney fees, advertising or other costs.
 - 3. That no costs having been incurred, no assessments shall issue.
- 4. That said improvement district be and the same is hereby abandoned.
- 5. That for the benefit of persons concerned with the conditions of titles within said area, an emergency is hereby declared for the preservation of the public health and safety and the furtherance of highway improvements, and by reason whereof this resolution shall take effect from and after its adoption and approval.
