It further appearing to the Board that the basis of salaries heretofore allowed County Officers in said County has been upon the ceness of showing Tulsa County to have a population of thirty four (34,000) thousand people.

It therefore appearing to the Board of County Commissioners of Tulsa County,
Oklahoma, that the County officers of Tulsa County, are entitled to their
compensation upon a basis of population as it now exists, and as shown by said last
census, instead of the basis of population taken over se ven years past, when
the population of said County was less than one half as much as it is now.

BE IT THEREFORE RESOLVED by this Board upon motion of R.A. Martin. and seconded by W.L. North. and duly carried by the unanimous vote of said Board, that from and after the first day of July, 1917, said County officers of Tulsa County, Oklahoma, be paid upon the basis of population of over sixty (60,000) thousand people, and in the salaries as hereinafter enumerated and set out as follows, to-wit:
