

County, as shown by the 1910 census, and that since 1910, and since the taking of said census, the population of County has increased to about One Hundred (100,000) Thousand, and the volume of business has increased in proportion; and further that the cost of living within the last two years has increased to at least double what it was heretofore;

And further due to the fact that the deputies and assistants to the above named officers are not now receiving a sufficient salary to constitute a living wage at the present prices:

And further due to the fact that several of the real competent assistants in the various departments above named have already resigned because of increased enumeration that they could procure in the employ of private interests, and further that the other competent deputies and assistants in said departments are treating too, and will resign because of better opportunities open to them unless some increased enumeration is allowed them by the County.

The Board hereby resolves and finds after a thorough investigation of the facts, and after hearing the evidence, upon motion of R.A. Martin, and seconded by W.L. North and the unanimous vote of the Board that in order to pay the employees, assistants and deputies in the different departments a living wage, to keep the competent help, and dispose of the volume of business, it will be necessary to increase the salaries and number of deputies, assistants and employees, in the different departments so that each officer shall be allowed the number of deputies, assistants, or employees, at a salary as follows; to-wit:

COUNTY TREASURER:

One First Deputy, at \$140.00 per month,
One Second Deputy, at \$115.00, per month,
One Third Deputy at, \$105.00, per month,
Four Additional Deputies at \$100.00 per month.

COUNTY CLERK.

Two First deputies at \$125.00 per month.
Two Second deputies at \$100.00 per month.
Four Third Deputies at \$90.00 per month.
Four Additional Deputies at \$75.00 per month.

COUNTY SUPERINTENDENT OF PUBLIC INSTRUCTION;
One first deputy at \$90.00 per month.

COURT CLERK.

Three First Deputies at \$125.00 per month.
Three Second Deputies at \$100.00 per month.
Three Third Deputies at \$95.00 per month.

SHERIFF.

One First Deputy at \$125.00 per month.
One Second Deputy at \$100.00 per month.
One Third Deputy at \$90.00 per month.

COUNTY ASSESSOR.

One First Deputy at \$125.00 per month.
One Second Deputy at \$100.00 per month.

COUNTY ATTORNEY;

One First Assitant at \$150.00 per month,
One Second Deputy at \$125.00 per month,
One Third Deputy at \$125.00 per month,
Stenographer at \$100.00 per month,
Evidence man at \$90.00 per month.

IT IS THEREFORE, ordered by the Board by resolution upon motion duly made, seconded and carried, that the above named County offices be allowed, deputies, assistants and employees with a monthly compensation, as above set out, and vouchers in payment of the above enumerated employees in the amount as set out,
