THE FULL FAITH, CREDIT AND RESOURCES of said County are hereby irrevocably pledged to the payment of this bond.

IT IS HEREBY CERTIFIED AND RECITED that all the acts, conditions and things required to be done precedent to and in the issuance of this bond have been properly done, happened and been performed in regular and due form and time as required by law, and that the total indebtedness of said county including this bond and the series of which it forms a part, does not exceed any constitutional or statutory limitation and that due provision has been made for the collection of an annual tax sufficient to pay the interest on this bond as it falls due and also to constitute a sinking fund for the payment of the principal hereof at maturity.
