

and shall be Nine Hundred Ninety Eight in number, of which Nine hundred ninety seven shall be numbered from one to nine hundred ninety seven inclusive, of the denomination of \$1,000.00 each, and one of which shall be numbered Nine Hundred Ninety Eight of the denomination of \$500.00 and shall be dated September 1, 1948, and become due and payable in their numerical order, FIFTY FIVE THOUSAND DOLLARS par value thereof on September 1, in each of the years 1950 to 1966, both inclusive, and SIXTY TWO THOUSAND FIVE HUNDRED DOLLARS par value thereof on September 1, 1967, and shall bear interest from their date until paid at the rates of \$385,000.00 par value, bonds numbered from one to 385 inclusive and maturing from 1950 to 1956 inclusive at 2% interest and \$330,000.00 par value, bonds numbered from 386 to 715 inclusive and maturing from 1957 to 1962 inclusive at 2½% interest and \$282,500.00 par value, bonds numbered from 716 to 998 inclusive and maturing from 1963 to 1967 inclusive at 2½% interest; said interest to be payable March 1, 1950, and semi-annually thereafter on the 1st day of September and March of each year, which installments of interest to date of maturity of principal shall be evidenced by appropriate coupons attached to each of said bonds and both principal and interest shall be payable in lawful money of the United States of America at the First National Bank and Trust Company of Tulsa, Tulsa, Oklahoma, or, at the option of the holder, at the Harris Trust and Savings Bank, Chicago, Illinois, or the Fiscal Agency of the State of Oklahoma in the City of New York, State of New York, or in the event of the discontinuance of such agency, then at the Manufacturers Trust Company in said City, and State of New York.
