

Section 4.

THAT beginning with the year 1947, a continuing annual tax sufficient to pay the interest on said bonds when due and for the purpose of providing a sinking fund with which to pay the principal of said bonds when due shall be and is hereby ordered levied upon all the taxable property of said county, in addition to all other taxes, said sinking fund to be designated "The County Bridge Bonds of 1947 Sinking Fund." Said tax shall be and is hereby ordered certified, levied and extended upon the tax rolls and collected by the same officers, in the same manner and at the same time as the taxes for general purposes in each of said years are certified, levied, extended and collected; that all funds derived from said tax shall be placed in said sinking fund which, together with all interest collected on same, shall be irrevocably pledged to the payment of the interest on the principal of said bonds when and as the same fall due.
