APPLICATION TO BUILD A PRIVATE
TELEPHONE LINE.

To the Honorable Commissioners of Tulsa County,
Tulsa, Oklahoma

I, the undersigned, hereby make application to your Honorable Body for permission to build, construct, maintain and operate a private telephone line, along certain streets and premises in certain additions to the City of Tulsa, Oklahoma, and outside the corporate limits thereof, said line to be located as hereinafter designated:

Beginning 625 feet east of the Southwest Corner of the intersection of Delaware and Haskell Streets of the City of Tulsa, Tulsa County, Oklahoma, being the Northeast Corner of what is known as Reddin Addition to said City of Tulsa, thence east 345 feet in a straight line to
