The undersigned, having examined the plans and specifications, and being familiar with the location and character of the work to be done and performed, hereby proposes to furnish all labor, materials and equipment, and to construct and complete in accordance with the Oklahoma State Standard Specifications, supplemented by the Special provision that the Contractor use a sub grade planer between the concrete mixer and the fresh concrete, and use a ten (10') foot float in finishing the surface, and in accordance with Tulsa County Standard Plan written directions thereon, the paving with Concrete and otherwise improving the hereinafter described highway in Tulsa County Oklahoma, the quantities as shown being approximate and subject to actual measurements of completed work in place, with quantities to be paid for at the unit item prices as bid:

DESCRIPTION OF WORK.

"One (1) mile of County Highway on Turkey Mountain, being Mile 3 of Section "Z-1", or between sections 34 and 35 Township 19 North, Range 12 East.

Two (2) miles west of Red Fork, being Miles 2 and 3 of Section "ZZ" of between Sections 21 and 28, 20 and 29, Township 19 North, Range 12 East."
