NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, State of Oklahoma, that the Treasurer of Tulsa County, Oklahoma, the Chairman of the Board of County Commissioners, and the County Clerk of such County be, and they hereby are, authorized and directed to take steps to obtain and to enter into an agreement with the Town of Burfalo, Oklahoma, for the refunding and paying of the Waterworks Improvements Bonds of 1921 of the Town of Buffalo, Oklahoma, now held by Tulsa Jounty, Oklahoma, or its subdivisions, by the issuance of Refunding Bonds of the Town of Buffalo, Oklahoma, on the terms and conditions hereinabove set out, and in connection therewith, to enter into such contracts and proposals, and to do all things required by law, so as to effect a refunding of such bonds.

WHEREFCRE, an emergency is hereby declared to exist, and this resolution shall be in full force and effect immediately from and after its passage and approval.
