Beginning at the southwest corner of the southeast quarter of the southeast quarter of the southeast quarter of Section 8; thence running easterly along the south line of Sections 8 and 9 to the southwest corner of the southeast quarter of the southeast quarter of Section 9; thence southeasterly to the southwest corner of the northwest quarter of the northwest quarter of Section 15, thence southeasterly to the southwest corner of the southeast quarter of the southeast quarter of Section 15; thence southeasterly to the southwest corner of the northwest quarter of Section 23; thence easterly along the centerlines of Sections 23 and 24, to the intersection of said centerline with the right hand meander line of the Arkansas River; thence northwesterly and southwesterly along the right meander line to the intersection of said line and a line running parallel with and 660 feet west of the east line of Section 8; thence southerly to the point of beginning; containing 2650 acres, more or less.
