RESOLUTION

WHEREAS, there has been established a Federal Aid Secondary Road System for the County of Tulsa, State of Oklahoma, and approved by Federal Works Agency, Public Roads Administration, and the State Highway Commission:

AND WHEREAS, it is deemed desirable now that the system heretofore established be enlarged and added to,

NOW, THEREFORE; be resolved that the Department of Highways of the State of Oklahoma, is hereby requested to revise the Secondary System heretofore established, by adding the following Roads, to-wit:

Thirty-sixth Street north from the Osage - Tulsa County line east approximately one and one-half mile to its intersection with North Peoria Avenue and designated as Federal Aid Primary Route 25, also being State Highway No. 11, for the following reasons:

REASONS

Since Federal Aid Secondary Route 5714 Revised - Osage County, as now established through the Southeastern portion of Osage County approachs the Tulsa County Boundry line between Sections 14 and 23, Township 20 North, Range 12 East, has been requested by Mr. G. L. Johnston, Engineer for the Farm to Market Roads for the State Highway Commission that Tulsa County should request an addition of this one and one-half mile section to our Secondary System. All of which should be done.

Adopted this 24 day of August, 1948, by the unanimous vote of said Board of County Commissioners.
