

Beginning at a point on the South line of Section 7, Township 19 North, Range 12 East, and 2489.9 feet more or less West of the SE corner of said section and where a 1001' curve (angle 24032') whose tangent bears North 57013' East intersects said Section line; thence North-easterly around said curve a distance of 1724.5' to a point of tangency; thence North 81045' East a distance of 639' to a point of curve, thence around a 300' curve to the right (angle 31001') a distance of 216.7' to a point on the East line of Section 7, Township 19 North, Range 12 East, and 615' more or less North of the SE corner of said Section 7, Township 19 North, Range 12 East, and containing 5.92 acres more or less, all in Tulsa County, Oklahoma;

A strip of land in Section 8, Township 19 North, Range 12 East, being 50' on either side of a center line described as follows:

Beginning at a point on the West Section line of Section 8, Township 19 North, Range 12 East, and 615' more or less North of the SW corner of said Section and where a 300' curve (angle 31001') whose tangent bears North 81045' East intersects said section line; thence Southeasterly around said curve a distance of 817.2' to a point of tangency; thence South 67014' East a distance of 934.5' to a point, said point being 1652.2 feet East and 116.8 feet north of the SW corner of said section 8, Township 19 North, Range 12 East, Tulsa County, Oklahoma, and containing 4.02 acres, more or less, in Tulsa County, Oklahoma.
