Greetings:

We, the undersigned, residents, qualified voters, and propertyowners of the Pomeroy Addition in Tulsa County State of Oklahoma, upon a fact of a verbal agreement between said parties undersigned and a Mr. \_\_\_\_\_ Roberts, of same Pomeroy Addition Tulsa County, State of Oklahoma, whereby that upon, that upon the acquiring by deed of certain lands on Kerr Street between Federal and Barton Streets; that Mr. \_\_\_\_\_ Roberts would give title to certain lands between Federal and Barton Streets (to be known as University Street) same to be opened up as a street for traffic.

The parties undersigned have deeded said Mr. \_\_\_\_\_ Roberts land as stated above, but said Mr. Roberts now refuses to open said land between Federal and Barton on University Street for traffic.

Upon this fact, undersigned, do hereby petition the Honorable County Commissioners of Tulsa County, State of Oklahoma, to open up said University Street for Traffic and enforce said contract with said Mr. Roberts.
