

Tulsa Oklahoma, Oct. 5 1908

The Commissioners of Tulsa County Oklahoma met in regular session in County Clerk's Office, Present W. L. North, Ed. L. H. Cleveland, Minutes of meetings held during the second quarter 1908, were read and approved on motion of Board. As Chandler & Co. refused to take the Fisher schoolhouse at price named the contract was awarded to R. M. Sear the next, lowest bidder at a price of \$656.56 on motion of Board. The petition of George Francis for the use of the public highways of Tulsa County for Gas Line was read and on order was granted to said George Francis for the use of said highways of Tulsa County Oklahoma for said Gas Lines as shown on plat filed in County Clerk's Office.

The report of viewers of Road connecting Main Street of Town of Bixby with the Public road south was on motion adopted, and Warrants were ordered for amounts named in their ward of damages. The Petition Enos, Grimes & Esley for road in Bellview & Oakdale addition was read and the following viewers were appointed S. D. Maxey, Elva Barrows, & J. W. Whitney to meet County surveyor on the 3rd Nov. 1908. The following Resolution was on motion adopted by Board and ordered spread on the minutes of meeting. All Bridge Petitions were laid over until January meeting by order of board.

Resolution,

Whereas under and by virtue of Section 5, Article V of the Constitution of the State of Oklahoma, the powers of the initiative and referendum reserved to the people by said constitution for the state at large are reserved (to the people by said constitution for the State at) to the legal voters of every county and district therein as to all local legislation and action in the administration of County and District Government, in and for their respective counties and districts and the authority vested in the boards of County Commissioners to provide for the time of exercising said initiative and referendum powers; and whereas, the needs and interests of the School Districts of Tulsa County, in the State of Oklahoma, demand that a time shall be fixed for exercising the referendum powers as to local legislation and action therein, to the end that the operation of such legislation and action may not be unduly delayable

Now, Therefore, be it resolved and ordered by the Board of County Commissioners of the County of Tulsa and State of Oklahoma, that the powers of referendum reserved by the Constitution of the state of Oklahoma to the legal voters of school districts therein as to all local legislation and action in the administration of school district government in and for said school districts therein to be exercised in the manner prescribed by an act of the legislature of the state of Oklahoma, entitled; "An act to provide for carrying into effect the initiative and referendum powers reserved by the people in articles 5th and 18 of the
