District No. 1 came on for hearing. One protest was entered against said proposed District, by R.W.McDowell. After some discussion, the following Resolution was passed by the Board of County Commissioners.

WHEREAS, On the 16th. day of July, 1923, a petition signed by fifty or more of the holders of titles to land embraced within the proposed District, was filed with the Board of County Commissioners of Tulsa County, Oklahoma, accompanied by a map of said District drawn to a scale of not less than 2 inches to the mile and showing the proposed boundaries of said District and the source of the water supply, praying for the formation of a water improvement district under the terms and provisions of House Bill No. 512 as passed by the 1923 Legislature, to be known as Water Improvement District No. 1, Tulsa County, Oklahoma; and

WHEREAS, At the same time there was filed with said petition a good and sufficient bond in double the amount of the probable cost of organizing such district, conditioned that said bondsmen would pay all costs in case said organization should not be effected, and such petition having been approved by said Board of County Commissioners; and

WHEREAS, Upon the filing of said petition and said Bond, the said Board of County Commissioners duly ordered said petition to be heard upon the 6th. day of August, 1923, at 9:00 o'clock A.M., or as soon thereafter as the matter could be heard, and further ordered the County Clerk to give due and legal notice thereof; and

WHEREAS, Said petition and the notice of the hearing thereon was duly published in the Skiatook News at Skiatook, Oklahoma, in the issues of July 19th. and July 26th. 1923.

NOW, THEREFORE, Said matter coming on for a hearing on this 6th. day of August, 1923, upon said petition praying for the organization of said waterimprovement district, said Board of County Commissioners of Tulsa County, Oklahoma, having hheard the evidence both for and against said petition, and being fully advised in the premises, finds, that it will be conducive to the public health and to the public utility to form such improvement district as prayed for in said petition.

It is further orderee by said Board of County Commissioners for Tulsa County, Oklahoma, that the said water improvement district be and the same is hereby established with in accordance with the prayer of said Petition, subject to the result of an election to be held therein, according to law, and that the following shall be the boundaries of such improvement district, to-wit:

Beginning on the 96th. Meridian at the southwest corner of Section 23, Township 29 N., R., 12 E. Tulsa County, Oklahoma. and running thence East along the Section line between Sec. 23 ond the North and Sec. 26 on the South and Sec. 24 on the North and Sec. 25 on the South in said T. 20 N., R. 12 E., and continuing East along the projection of said Section Line between Sec 19 on the North and Sec. 30 on the South, to the S.E.Cor. of said Section 19 in T. 20 N., R. 13 E. Tulsa County, Oklahoma, thence North along the Section Line dividing Sec. 19 on the West and Sec. 20 on the East in said T. 20 N., R. 13 E., Tulsa County Oklahoma, and following the projection of said Section Line North to the S.E.Cor. of Sec. 7, T. 21 N., R. 13 E., thence West along the Section Line dividing said Section 7 on the North and Sec. 18 on the South in T. 21, N. R., 13 E., Tulsa County, Oklahoma, to the S.W. Cor. of said Section 7, thence North along the Section Line dividing said Sec. 7, T. 21 N., R. 13 E., on the East and Sec. 12 T. 21 N., R 12 E. on the West and following the projection of said Section Line North to the N.E. Cor. of Sec. 24, T. 22 N., R. 13 E. thence West along the Section Line dividing Sec. 13 on the north and said Sec. 24 on the South and the projection of said Section line on the 96th. Meridian, thence South along said 96th. Meridian to the place of beginning.

That said Water Improvement District shall be known as Water Improvement District No.1, Tulsa County, Oklahoma.

Oklahoma, that the County Clerk shall give notice of the election so to be held within said proposed District, which notice shall describe the boundaries of said district as herein established, shall designate the name of said proposed district, shall require the electors to cast ballots which contain the words "Water Improvement District No. 1, Tulsa County, Oklahoma, Yes", or "Water Improvement District No. 1, No", or words equivalent thereto, and also shall contain the names of the persons to be voted for to fill the elective offices as follows:

and said notice shall be published for at least three weeks prior to said election in some newspaper of general circulation within said District.

It is further ordered that said election to determine whether or not said improvement district shall be organized shall be held upon the 31st. day of August, 1923.

Except, that land of R.W.McDowell be and his hereby eliminated.
