THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS in regular adjourned meeting assembled that the County Attorney be and he is hereby instructed and directed to institute a suit against said Wayne L. Dickey and the Surety upon his official bonds, for the value of said bonds, together with the interest thereon, thus unlawfully disposed of.
