MANAGEMENT CONFERENCE November 13, 1997

The Board of County Commissioners of Tulsa County met at 9:30 a.m., with the following members present: Robert N. Dick, Chairman, John Selph, Lewis Harris. Members absent: none. Others present: Sheriff Stanley Glanz, Bill Thompson, Wayne Carr, Chad Higgins, Richard Bales, Chris Newbold, Neal Kennedy, and Pam Hayes.

Chairman called the meeting to order at 9:32 a.m., and the following business was transacted:

Glanz advised the jail population was increasingly moving toward the 900 point. He said it is important to establish what a day is in the jail, particularly as the negotiations with Corrections Corporation of America (CCA) continue. Selph mentioned this subject had been discussed during the November 11, 1997 CCA contract negotiation team meeting and that Lt. Mark Williamson is working upon a recommendation to define county jail population.

Glanz discussed the investigation being held regarding the inmate death which occurred in the jail on October 14, 1997. He said it may take six weeks for the medical examiners report but an internal investigation is progressing well. A letter has been sent to Wexford Health Sources requesting an examination of their policies and Wexford is being more cautious in sending ill inmates to the hospital. Glanz pointed out that the Wexford medical staff have the credentials to make the decision upon whether or not to send an inmate to
