payment thereof have not been had and taken place; and

Whereas, the County Commissioners deem it more expedient and to the best interest of all parties concerned, and to the best interest of the proposed drainage district, and for the furtherance of said work that all the proceedings be started new, Now, Therefore:

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA? COUNTY, STATE OF OKLAHOMA:

Section 1: That all proceedings heretofore had, including the petition, the bonds here tofore executed, the appointment of viewers, both by the County Commissioners and the District Judge, and the employment of the engineers in this matter, be and the same are hereby revoked, annulled and set aside, with the understanding that the County Commissioners will entertain a petition to establish said drainage district and perform the work contemplated, especially the construction of the drainage ditch and the taxing of the property liable therefor.

Section 2: That such petition, necessary bond, orders and resolutions will in due course as presented and filed with this Board or the Clerk thereof, receive due consideration and action will be had and taken thereon as if no proceedings had prior to this date been done or taken place.

Section 3: That by reason of the necessity for prompt action in said matter that the residents of such district may take the proper and necessary steps for the establishment of a drainage district and the construction of a drainage district therein, it is deemed and hereby declared necessary for the preservation of the public health, peace and safety, that this resolution shall become operative immediately, wherefore, an emergency is hereby declared to exist and this resolution shall be in full force and effect immediately from and after its passage and approval.

## PETITION.

TO THE BOARD OF COUNTY COMMISSIONERS, OF TULSA COUNTY, STATE OF OKLAHOMA.

We, the undersigned, being residents of Tulsa County, State of Oklahoma, and affected and subject to assessment for the construction of the drainage ditch hereinafter indicated, hereby petition your board to cause to be constructed an open drainage ditch with sloping banks, upon and along the general lines hereinafter set out, to wit: "Beginning at a point 334.4 feet west from the northeast corner of let 2, Section 11, Township 19 North, Range 12 East, said point being on the north line of said Lot 2; thence northwesterly through Lot 7, Section 2, for a distance of 597 feet to a point; thence northwesterly to the west Seven line of said lot/at a point approximately 200 feet south of the northwest corner of said lo 5; thence not thwesterly on the same course through Lot 8, Section 3, thence northwesterly through the north half of the southwast quarter of section 3 to a point on the west line thereof and approximately 400 feet south of the center of said section 3; thence through the north half of the southwest quarter of said section 3, 475 feet to a point; thence, westerly the the north half of the southwest quarter of said section 3, to the west line thereof at a point 300 feet south of the east and west center line of said section 3; thence west through the northeast quarter of the southeast quarter of section 4, to the west line thereof thence southwesterly through the northwest quarter of the southeast quarter of said Section 4;
