

second part and filed each month and that all payments shall be due and payable at the end of each month.

All photographing of said records to be done at the County Court House in the City of Tulsa, County of Tulsa, Oklahoma, under the supervision and control of the County Clerk and that second party shall cause all instruments to be recorded, to be delivered at the office of the County Clerk, to the party of the first part for such recording.

That party of the second part shall furnish a suitable room or place for all such recording in the County Court House, properly equipped for photographing and operating the photographic recording, at the expense of the party of the second part.

The official Bond of the said party of the first part, which shall be in the amount of \$10,000.00 shall be liable for the prompt and safe return of all such instruments to the office of the County Clerk.

All photographed sheets of record made shall be perforated for binding and bound when delivered to the party of the second part. All binding to be done by the party of the first part in a neat and workmanlike manner and that all covers, bindings and necessities incident to the proper binding shall be furnished by the party of the second part and at its expense; the first party agreeing to trim all sheets after the same is bound in the record book so as to make the book and record present a finished and complete appearance.

Party of the first part has with the submission of this contract tendered a good and sufficient bond in the sum of \$10,000.00, conditioned as is required by Section 2, Chap. 50 of the Session Laws of Oklahoma for 1923, and said bond has been approved, and heretofore by resolution duly made and entered upon the records of Tulsa County, Oklahoma, the party of the second part having adopted a system of photographing records for the office of the County Clerk of said Tulsa County, Oklahoma. Party of the second part have the right to cancel contract on poor workmanship of records.

MEMORANDUM OF AGREEMENT FOR AGRICULTURAL WORK.

BETWEEN

TULSA COUNTY

and the

OKLAHOMA AGRICULTURAL AND MECHANICAL COLLEGE EXTENSION DIVISION

in co-operation with the

UNITED STATES DEPARTMENT OF AGRICULTURE.

OBJECT:

For the purpose of assisting the farmers of this County with their many problems of soil fertility, terracing, economic crop production, live-stock breeding, feeding and management, the prevention and control of crop diseases and insect pests, and the prevention and control of live-stock diseases, through educational means, also their problems of grading, standardizing and marketing their farm products, the Extension Division of the Oklahoma Agricultural and Mechanical College proposes to establish in co-operation with the County, a direct service which shall
