

for the proposed drainage ditch and lateral ditches, contract forms, and bidding sheets to the satisfaction of the county engineer and your Board, for the sum of three (3) per cent of the estimated cost of the work.

Second: We propose to furnish on construction, supervision, inspection, monthly estimates, stakes and all necessary construction data for the guidance of the contractor to the completion and acceptance of the work, and the issuance of the bonds for the further sum of four (4) per cent of the estimated cost of the work, as shown by the final estimate made to the contractor.

The cost of engineering being under the law a part of the improvement is chargeable to the property benefited, and if the work is done no cost will accrue to the county, and if the work is abandoned after the surveys are made, the cost of the surveys are to be paid out of the petitioners bond.

AN ORDER RELATING TO THE CONSTRUCTION OF A DRAINAGE DITCH
AND THE CREATION OF A DRAINAGE DISTRICT TO BE KNOWN AND
DESIGNATED PARK VIEW DRAINAGE DISTRICT NO. _____.

WHEREAS, there was filed with the county clerk and there has been presented to the Board of County Commissioners of Tulsa County, State of Oklahoma, a petition signed by five or more residents of said county, and

WHEREAS, said petitioners request that this Board cause to be constructed a drainage ditch for the purpose of draining the following described lands, to wit:

"All of Section 5 and section 4, except that part of Section 4 lying south of the north right of way line of the Sand Springs Railway Company, and all of section 3, except Irving Place, New Irving Place, Arlington Heights, and Bunker Hill addition, being additions to the City of Tulsa, State of Oklahoma, and except a triangular piece of ground belonging to T F Renfer, consisting of six acres, being in the northeast corner of the
