Harris for the estate of John Eshman, covering realestate for the year 1931, be and the same is hereby reduced 40% of the assessed valuation and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the application for correction of erroneous assessment filed by the Trustees for former stockholders of Tulsa Building and Loan Association covering realestate for the years 1930, 1931 and 1932, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
