WHEREAS, on January 15, 1927 a Journal Entry of Judgment in the above styled and numbered cause was signed by Hon. Edwin R. McNeill, Judge of Division No. 2 of the District Court of Tulsa, Oklahoma, and,

WHEREAS, it appears that the defendant C C Daily in said cause was one of the sureties upon the forfeited appearance bond sued upon therein and that he was the owner of Lot 19, Block 2 Crutchfield Addition to the City of Tulsa, Oklahoma, but by or through inadvertence mistake or otherwise the property by him scheduled upon said bond was given as living and being in Block 1 (one) of said addition, and whereas by mesne conveyances of said lot 19 B 2 Crutchfield Addition the title thereto passed to innocent purchasers and the record title of said lot did not disclose any notice other than that the title was unencumbered and that the person owning said E D Walters had no notice or knowledge of the facts of and concerning the execution of said appearance bond, the forfeiture thereof and consequent judgment thereon. To the end of therefore that the title of said lot may be cleared of record and especially of the judgment in said cause against C. C. Daily and in view of the facts foregoing, a partial satisfaction of the judgment heretofore referred to is hereby entered releasing said Lot 19 Block 2 Crutchfield Addition to the City of Tulsa, aforesaid, from the operation of said judgment or any part thereof.
