There was then presented to this Board, a petition for the appointment of S. B. Allton as constable within and for Jenks township, and upon motion of W. L. North seconded by Ed dalton, the said S. B. Allton was appointed constable. Motion carried.

There being no further business coming beforethe Board for consideration, on motion, duly made and seconded, the Board adjourned to meet in their next regular session, Monday, June 6th, 1921.
