NOTICE? INDIAN LAND TAXES.
" In veiw of the fact that certain lawyers are making contracts with pe owners of Indian Homesteads, both in the Creek and Cherokee Nations for the purpose of instituting suit for the recovery of taxes paid to Tulsa County on these homesteads since Statehood, we desire to state that cases of similar nature have been tried and are now pending in the Supreme Court from Creek County, and the decision there will very likely be decisive of the question in Tulsa County.
That being true, it would hardly seem wise or necessary for these suit to be instituted against Tulsa County before the final determination of the Creek County case.
