CONTRACT AND LICENSE AGREEMENT

This contract and license agreement, made and entered into by and between the TULSA STATE FAIR, a Department of Tulsa County, Oklahoma, through its Directors, with the approval of the County Commissioners of said County, as the Grantor, and INTERNATIONAL PETROLEUM EXPOSITION, of Tulsa Oklahoma, Grantee.

WITNESSETH: That, Whereas, Grantee desires the right and privilege of using an additional space or plat of ground adjoining that which they heretofore acquired on the TULSA STATE FAIR GROUND'S property, being a portion of

The SE $\frac{1}{4}$ of Section 9, Township 19 North, Range 13, East, and the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 9, Township 19 N., Range 13 East, in Tulsa County, Oklahoma"

to be used by Grantee as a part of, and in connection with the grounds heretofore acquired for the specific purpose of erecting thereon a modern five room, frame dwelling house, suitable for Superintendent's residence of the Exposition Grounds, also an Emergency Red Cross Hospital; and also, suitable rest rooms and toilets for use during the PETROLEUM EXPOSITION which plat of ground embraced in this license and contract agreement is particularly described as follows:

Beginning at a point 64.5 feet East of the Northwest corner property line, heretofore leased to the INTERNATIONAL PETROLEUM EXPOSITION; thence North 90 feet, thence East 145 feet; thence South 90 feet; to the North side property line of the INTERNATIONAL PETROLEUM EXPOSITION, and

WHEREAS, Grantor herein has consented to lease and license said plat of ground to the INTERNATIONAL PETROEEUM EXPOSITION for said purpose.

NOW, THEREFORE, it is hereby stipulated and agreed by and between the Grantor and Grantee as follows, to-wit:

That said Grantor does hereby grant, license and let unto the Grantee, from date until the expiration of their license or lease upon the grounds now occupied by it, all that part or plat of ground asst above described, for the specific use and purpose only as above expressed; that is to say, for use in connection with other grounds and upon which to erect a Superintendent's residence, Emergency Red Cross Hospital, rest rooms and toilets for use during the INTERNATIONAL PETROLEUM EXPOSITION; but it is expressly agreed and understood between the parties hereto, that the use of said ground by the INTERNATIONAL PETROLEUM EXPOSITION, is not to, in any way or manner, affect the use of adjoining grounds by the TULSA STATE FAIR BOARD; and it is expressly further understood and agreed by and between the parties hereto that when such plat of ground ceases to be used by the INTERNATIONAL PETROEEUM EXPOSITION for the uses and purpses for which this grant is made,
