WEDNESDAY, DECEMBER 28th, 1938.

Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 2:00 o'clock P.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

John H. Miller, Chairman presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the Depository Agreement between The First National Bank & Trust Company of Tulsa, and the Board of County Commissioners of Tulsa County, Oklahoma, dated December 14th, 1938, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Miller, that Dr. B. A. Waynes be instructed to let a contract for laundry at the Municipal Hospital to the Banner Laundry in the amount of \$75.00 per month for the months of December, 1938 and January, 1939. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the affidavit of erroneous assessment filed by J. P. Norton, Receiver for the K.C. Auto Hotel, and approved by Dan A. Rowe, County Assessor, covering Corporation tax for 1938, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
